Tuition charge is based on the entire year, but for your convenience, may be paid monthly. Tuition payments are due the 1st day of each month. A late fee will be assessed on any balance not paid by the 10th of each month. All tuition, late fees, performance fees, costume fees, must be paid in full before any student is permitted to perform in any production. Tuition, registration fees, costume payments and performance tickets are non-refundable. Missed classes may be made up in the same level or a level below within one month's time of an absence. To withdraw or change a class, you must notify the front desk or office in writing 30-DAYS prior to THE NEXT BILLING. Classes are subject to cancellation or rescheduling at GN's discretion. GN is not responsible for student property. Any student destroying GN property will be promptly dismissed and expelled on the basis of behavior and/or the actions of their parents at GN's discretion. **(please read remainder of the policies on the back)**
